**AGREEMENT FOR WEDDING PHOTOGRAPHY COVERAGE**

This agreement, entered into on \_\_\_\_\_ is between Angela R. Talley Studio in the State of Indiana and the undersigned (hereinafter referred to as "Client") relating to the wedding of that will take place on \_\_\_\_\_.

**SERVICE COVERAGE:** The parties agree that Angela R. Talley Studio will furnish the services of professional photographers. Angela R. Talley and a trained assistant (if needed) will begin unlimited photographic coverage at starting \_\_\_\_\_ at the time appointed by the couple. The fee for professional services (exclusive of products) for reservation and event coverage is \$ \_\_\_\_\_. It is agreed that Angela R. Talley will be the sole still photographer employed for the wedding day. Simultaneous photographic coverage by another contracted photographer shall release Angela R. Talley from this agreement and the professional fee will be retained. In addition, we request that guests and professional videographers not take pictures of our set up/posed shots, as doing so may delay the process and effect or ruin the outcome of your photographs. Due to the fact that weddings are uncontrolled events, we cannot guarantee any specific photograph or pose. We will, however, attempt to honor special requests.

**PAYMENT POLICY and EXPENSES:** A fee of \$ \_\_\_\_\_ is retained herewith to reserve event coverage for the service coverage specified above. This fee is nonrefundable, but may be reapplied (subject to availability) if the event is rescheduled. A final payment of \$ \_\_\_\_\_ will be paid by the Client no later than two weeks prior to the event, plus reimbursement of applicable airfare, hotel and transfer expenses incurred by Angela R. Talley Studio in performing the photographic duties expressed herein

**PRODUCT PRICING:** Pricing is defined on our price list. All prices quoted for professional services, photographs and albums are valid for a period of two months following the date of the wedding. Orders placed after two months following the wedding are billed at the studio's currently published prices, which may be greater.

**USAGE OF IMAGES:** Angela R. Talley Studio maintains usage of all images from your wedding for promotion purposes including marketing on our website, printed materials, sample wedding albums etc.....

**WEDDING ALBUM/BOOK COMPLETION:** If you have not finalized your wedding album design within 6 months after the wedding, we will use the album design given to you at the time you received your proofs/proof magazine. The album/book will be completed as we designed initially and shipped to you.

**LIMITATION of LIABILITY:** While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, Angela R. Talley Studio's entire liability to the Client for claim, loss or injury arising from Angela R. Talley Studio performance is limited to a refund to Client of the amount paid for services. Because this is an uncontrolled event, Angela R. Talley Studio cannot guarantee delivery of any specifically requested image(s). As mentioned above, if our services are canceled for any reason, the deposit paid to reserve the date is nonrefundable. In the unlikely event of persona illness or other circumstances beyond the control of Angela R. Talley Studio, a substitute photographer of high qualifications, subject to the acceptance by Client prior to the event, may be dispatched by Angela R. Talley Studio to fulfill the obligations of photography herein contracted. In such case that Client declines Angela R. Talley Studio sending of a substitute photographer, Client may elect instead to terminate this agreement and receive a full refund of all deposits paid to Angela R. Talley Studio.
